Latest Updates:

• Site Construction:

- City inspection items have been addressed, with three additional items identified during reinspection. Solutions are being provided.
- The pickleball court is under construction, with paving expected in the first week of October.
- The Pool Department of Health (DOH) inspection passed; full approval pending upon receiving the clubhouse CO, which is currently on hold due to ADA bathroom issues.
- All garage doors have been completed; electrical trims are in progress.
- Gate gear installation is scheduled for Wednesday.
- Utilities have been tracked, and the water/sewer installations are complete.







B. Vertical Construction

Latest Updates:

• Building Inspections:

- Buildings 9 and 10 failed CO inspection due to HVAC labeling issues; corrections have been made, and inspections have been rescheduled. Fire inspection for Buildings 11 and 12 is pending revised calculations for sprinklers.
- Acceptance walks for Buildings 8, 10, 11, and 12 will occur once tile backsplashes are installed. Tile work is currently being grouted in Phase 1.
- Countertops have been installed, with granite backsplashes expected to be completed this week in Phase 3.
- The ADA remodel of clubhouse restrooms is ongoing, with framing completed. Insulation is in progress, and flooring is pending in the first floor of Building 2; all others are completed.






